Your continued use of this Website after we make changes is deemed to be acceptance of those changes, so please check the Privacy Policy periodically for updates.

JM2 Clover Gaming SAS register under number 709952 having its registered office at 8 Avenida Anacaona, Torre Maz Azul, Los Cacicazgos, Dominican Republic ("Company" or "We") respects your privacy and is committed to protecting it through our compliance with this privacy policy (this "Privacy Policy"). This Privacy Policy describes the types of information we may collect from you or that you may provide when you visit the website [www.cloverland.io](http://www.cloverland.io) (our "Website") and our practices for collecting, using, maintaining, protecting and disclosing that information.

The Website may automatically collect data such as your IP address, your web browser type, your computer system, date and hours access to the website, etc...All the collected information will be used for tracking the traffic volume, type and traffic settings used for this website, in order to develop its design and layout and others administrative purposes and more generally to improve our services. You have the ability to block or delete cookies through web browser's settings used by you (ie: « Google Chrome »: Ctrl + Maj + Suppr; « Internet Explorer »: Alt+X then select the Internet Option menu; for « Mozilla firefox »: From the Tools menu in Firefox, select Options).

We do our best to protect your personal information, we cannot guarantee the security of your personal information transmitted to our Website. Any transmission of personal information is at your own risk. We are not responsible for circumvention of any privacy settings or security measures contained on the Website.

We collect several types of information from and about users of our Website and the CLOVERLAND platform and services, including information by which you may be personally identified, such as name, postal address, e-mail address, telephone number, social security number, passport number, date of birth, taxpayer or government identification number, or any other identifier ("personal information"); that is about you but individually does not identify you, such as gender, salary, and job, crypto-wallet address and/or about your internet connection, the equipment you use to access our Website and usage details.

Automatically as you navigate through the site. Information collected automatically may include usage details, IP addresses, device information including, but not limited to, identifier, device name and type, operating system, location, mobile network information, and standard web log information, such as your browser type, traffic to and from our site, and the pages you accessed on our website, and information collected through cookies, web beacons, and other tracking technologies.

We cannot delete your personal information without also deleting your user account. We may not accommodate a request to change information if we believe the change would violate any law or legal requirement or cause the information to be incorrect.

If you delete your User Contributions from the Website, copies of your User Contributions may remain viewable in cached and archived pages, or might have been copied or stored by other Website users.

## Automatic data collection technologies

As you navigate through and interact with our Website, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions and patterns, including:

- Details of your visits to our Website, including traffic data, location data, logs and other communication data, and the resources that you access and use on the Website.
- Information about your computer and internet connection, including your IP address, operating system, and browser type.

CLOVERLAND does not track its customers over time and across third-party websites to provide targeted advertising and therefore does not respond to Do Not Track (DNT) signals. Third parties that have content embedded on CLOVERLAND websites may set cookies on a user’s browser and/or obtain information about the fact that a web browser visited a specific CLOVERLAND website from a certain IP address.

The information we collect automatically is statistical data and may include personal information, but we may maintain it or associate it with personal information we collect in other ways or receive from third parties. It helps us to improve our Website and to deliver a better and more personalized service, including by enabling us to:

- Estimate our audience size and usage patterns
- Store information about your preferences, allowing us to customize our Website according to your individual interests
- Speed up your search
- Recognize you when you return to our Website

The technologies we could use for this automatic data collection may include:
